To Furnish & Install : TOUCHLESS WAVE SENSOR ON EXTERIOR, ONE ON INTERIOR, ONE ELECTRIC STRIKE AND ONE REMOTE RELEASE BY DESK. ONE RECORD DOOR OPERATOR.

NOTE: 110-volt wiring, low volt wire, wire raceways, access control, wall blocking and permits by others.

We hereby propose to furnish material & labor in its completion in accordance with the above specifications for the sum of :

FIVE THOUSAND, FIVE HUNDRED AND NINETY FOUR DOLLARS. \$ 5,594.00.

Labor rate included in said proposal is for weekday, daytime, non-prevailing wage rate. State & local tax has not been included in this price.

PAYMENT MADE AS FOLLOWS: Payment due upon completion. Payment by cash, check or credit card. If paid by credit card a 3% administration fee may be added to the total price. All accounts over 30 days shall incur a finance charge in the amount of 18%.

ATTORNEY FEES: In the event of any collection proceeding Southern Ohio Door Controls, Inc shall be entitled to recover all reasonable fees and expenses including, without limitation, costs of investigation, attorney's fees and litigation expenses incurred in connection therewith.

All material is guaranteed to be as specified. All work to be completed in a workmanlike manner in accordance with standard practice. Any alteration or deviation from above specifications shall be executed only upon a signed, approved, written change order and will incur an extra charge in addition to the original estimate. All agreements are contingent upon lack of strike, accident, state or national emergency or delay beyond our control. If the proposal is quoted installing the customer's material then Southern Ohio Door Controls, Inc. assumes no responsibility for the working condition of said material and would extend no warranty to these parts.
